Introduction

This directory is intended for providers and staff at local organizations that may encounter Spanish-speaking clients with limited command of English. We encourage social service providers to use the resources listed here to better serve Spanish-speaking clients. All the agencies and organizations included in this directory have developed some bilingual capacity to serve such clients—some agencies responded to our request for information by saying that instead of fully bilingual, someone on the staff was conversant in Spanish or that part-time bilingual staff was available on-call; we included those agencies in this directory. However, the personnel and the type of services offered by each agency often changes, and the agencies' bilingual capacity may not be current in all cases beyond May 2009.

In 2001, researchers with the Community Outreach Partnership Center at the University of Oregon surveyed local agencies and organizations to document their efforts in reaching Latinos in Lane County. Their assessment indicated that the surveyed agencies were still looking for more effective, culturally appropriate ways to get information out to Spanish-speaking residents. The report concluded that social service agencies in Eugene and Springfield needed: (a) to commit resources to their efforts to increase outreach and service effectiveness to Spanish-speaking clients; (b) more information about this particular community and its culture; (c) capacity-building strategies to increase the knowledge and skills of the staff regarding culturally appropriate outreach techniques; and (c) to combine the resources of several local organizations to meet these needs.¹ By the end of the decade, we are very pleased to report that 120 local agencies, organizations, and programs have already hired bilingual staff, translated portions of their websites to Spanish, or posted documents in Spanish. In particular, all pertinent information on Lane County official websites is available in Spanish. Also, all the social service providers that we consulted in Springfield offer bilingual services.

Introducción

Esta guía está destinada para el personal de organizaciones y agencias locales que presta servicios a personas que hablan español y que no se pueden comunicar fácilmente en inglés. Le recomendamos al personal que proporciona servicios sociales que utilice los recursos listados aquí para brindar mejores servicios a los clientes de habla hispana. Todas las agencias y las organizaciones incluidas en esta guía han desarrollado cierta capacidad lingüística bilingüe para servir a sus clientes—algunas agencias respondieron a nuestro pedido de información diciendo que tienen empleados que entienden español, aunque no son completamente bilingües o que pueden comunicarse con personal bilingüe por teléfono; esas agencias también han sido incluidas en esta guía. Sin embargo, el personal y la clase de servicios que ofrecen las organizaciones listadas en esta guía cambian con frecuencia. La capacidad de las agencias para servir a los clientes de habla hispana podría estar desactualizada después del mes de mayo de 2009.

En el 2001, investigadores del Community Outreach Partnership Center de la Universidad de Oregón encuestaron organizaciones y agencias locales para documentar los esfuerzos que estaban haciendo esas organizaciones para brindar servicios sociales a los clientes de habla hispana del Condado de Lane. Los investigadores concluyeron que las agencias todavía estaban tratando de encontrar formas eficientes y apropiadas para brindar información a residentes de habla hispana. El informe que produjeron indicaba que las agencias de servicios sociales de Eugene y Springfield necesitaban: (a) dedicar recursos para poder aumentar la efectividad de los servicios que brindaban a los clientes de habla hispana; (b) implementar estrategias para aumentar los conocimientos y las habilidades del personal con respecto a técnicas que fuesen culturalmente apropiadas; y (c) combinar los recursos de varias organizaciones locales para satisfacer esas necesidades. Al final de la década del 2000, informamos con mucho agrado que 120 agencias, organizaciones y programas locales ya han contratado personal bilingüe; varias organizaciones han traducido al español partes de sus sitios de Internet, incluyendo documentos traducidos. Además, todas las agencias de servicios sociales de Springfield que nosotros consultamos ofrecen servicios bilingües.

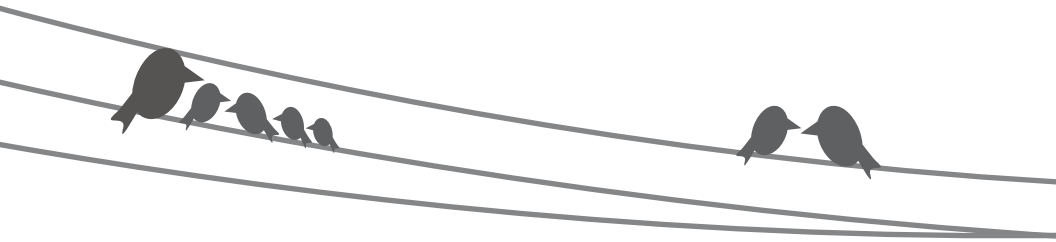
